John Bolt (Ph.D., University of St. Michael's College, Toronto) is professor of systematic theology at Calvin Theological Seminary. His most recent publications include *A Free Church, A Holy Nation: Abraham Kuyper's American Public Theology* (Eerdmans, 2001); "Why American Evangelicals Are Interested in Abraham Kuyper," *Radix* (Spring 1998); and "Abraham Kuyper and the Holland-America Line of Liberty," *Journal of Markets and Morality* (Spring 1998).

James D. Bratt (Ph.D., Yale University) is the director of the Calvin Center for Christian Scholarship and professor of history at Calvin College. He is the author of several publications, including *Abraham Kuyper: A Centennial Reader* (Eerdmans, 1998) and *Dutch Calvinism in Modern America: A History of a Conservative Subculture* (Eerdmans, 1984).

Charles W. Colson (J.D., George Washington University) is the founder and president of Prison Fellowship Ministries and a widely acclaimed evangelical author and speaker. He was the 1993 recipient of the Templeton Prize for Progress in Religion and one of the principal organizers of Evangelicals and Catholics Together, an ecumenical initiative, which promotes common Christian witness and mission in the world. His most recent publications include *Justice That Restores* (Tyndale House, 2001) and *How Now Shall We Live?* (Tyndale House, 2000) with Nancy Pearcey.

Avery Cardinal Dulles, S.J. (S.T.D., Gregorian University, Rome) is the Laurence J. McGinley professor of religion and society at Fordham University. Regarded as the preeminent Catholic theologian in America, he is the recipient of numerous awards including Phi Beta Kappa, the National Catholic Book Award, the Religious Education Forum Award, and the Cardinal Spellman Award for distinguished

achievement in theology. He has received 21 honorary doctorates and is an internationally known author and lecturer, having written 21 books and more than 650 articles, essays, and reviews. He is the first American Catholic theologian to become a Cardinal.

Craig M. Gay (Ph.D., Boston University) is associate professor of interdisciplinary studies at Regent College in Vancouver, British Columbia. He lectures on the relationship between Christianity and culture, modern Protestant thought, and current social issues. He has published two books, *Way of the Modern World* (Eerdmans, 1998) and *With Liberty and Justice For Whom?* (Eerdmans, 1991). His articles have appeared in the *American Journal of Sociology*, *Christian Scholar's Review*, and *Faith Today*.

Bob Goudzwaard (Ph.D., Erasmus University, Amsterdam) is emeritus professor of economics at the Free University of Amsterdam. He was elected to the Dutch Parliament in the 1970s and served for a time in a Christian policy research institute in The Hague. He now works with a coalition of Dutch churches to address Third World poverty and other aspects of an international Christian witness. His books include *Beyond Poverty and Affluence: Towards an Economy of Care* (Eerdmans, 1995); *Idols of Our Time* (InterVarsity, 1984); and *Capitalism and Progress: A Diagnosis of Western Society* (Eerdmans, 1980).

Sander Griffioen (Ph.D., Free University of Amsterdam) is emeritus professor of social philosophy at the Free University of Amsterdam. He is the author or coeditor of many publications, including *Geography and Worldview: A Christian Reconnaissance* (University Press of America, 1998) with Henk Aay; *Pluralisms and Horizons* (Eerdmans, 1993) with Richard Mouw; *Bringing Into Captivity Every Thought* (University Press of America, 1991) with Jacob Klapwijk and Gerben Groenewoud; and *Norm and Context in the Social Sciences* (University Press of America, 1990) with Jan Verhoogt.

Rev. David W. Hall is the director of the Kuyper Institute and pastor of Covenant Presbyterian Church in Oak Ridge, Tennessee. His publications include *The Arrogance of the Modern: Historical Theology Held in Contempt* (Calvin Institute, 1997); *Savior or Servant? Putting Government in Its Place* (Kuyper Institute, 1996); *The Practice of Confessional Subscription* (University Press of America, 1995); and *To Glorify and Enjoy God: A Commemoration of the 350th Anniversary of the Westminster Assembly* (The Banner of Truth Trust, 1994) with John L. Carson.

George Harinck (Ph.D., University of Leiden) is the director of the Archives and Documentation Center of the Reformed Churches in the Netherlands at Kampen and a staff member of the Historical Documentation Center at the Free University of Amsterdam. He has published widely on the cultural, political, and church history of Dutch Protestantism and its international relations in the nineteenth and twentieth centuries.

Peter S. Heslam (M.A., Cambridge University; D.Phil., Oxford University) is the director of the capitalism project and lecturer in social and economic ethics at The London Institute for Contemporary Christianity. He is also a tutor at Ridley Hall. He

has published widely in scholarly journals and is the author of *Creating a Christian Worldview: Abraham Kuyper's Lectures on Calvinism* (Eerdmans, 1998).

James C. Kennedy (Ph.D., University of Iowa) is assistant professor of history and a research fellow at the Albertus C. Van Raalte Institute for Historical Studies at Hope College. He has published two books: *Een weloverwogen dood: De opkomst van euthanasie in Nederland* (2002) on the history of euthanasia in the Netherlands, and *Nieuw Babylon in aanbouw: Nederland in de jaren zestig* (1995; reprinted in 1997 and 1999), which examines the transformations in Dutch society during the 1960s. William R. Luckey (M.B.A., Shenandoah University; Ph.D., Fordham University) is professor and chair of the department of political science and economics at Christendom College. Prior to this post, he taught at St. John's University, St. Francis College, Brooklyn, and Cardinal Newman College in St. Louis, Missouri. His articles have appeared in *Faith and Reason*, *Journal of Markets and Morality*, and various other periodicals. He is active in the Eric Voegelin Society and the American Political Science Association.

Mark A. Noll (Ph.D., Vanderbilt University) is the McManis Chair of Christian Thought and director of the Institute for the Study of American Evangelicals at Wheaton College. He is the author of the widely acclaimed *Scandal of the Evangelical Mind* (Eerdmans, 1994) and is regarded for his scholarly contributions in the area of American religious life. In recent years he has been a visiting professor at Harvard Divinity School, University of Chicago Divinity School, Westminster Theological Seminary, and Regent College of Vancouver, British Columbia.

Michael Novak holds the George Fredrick Jewett Chair in Religion, Philosophy, and Public Policy at the American Enterprise Institute in Washington, D.C., where he is the director of social and political studies. He was the 1994 recipient of the Templeton Prize for Progress in Religion and has been recognized for his scholarly contributions by the Slovak Republic, the Czech Republic, and the City of Provence, France. He has written over 25 books, including *The Spirit of Democratic Capitalism* (Simon & Schuster, 1982), which has been translated into more than a dozen languages.

Rev. Robert A. Sirico is cofounder and president of the Acton Institute for the Study of Religion and Liberty, a nonprofit, nonpartisan, educational organization. He received his M.Div. from the Catholic University of America and has been awarded honorary doctorates in Christian ethics (Franciscan University of Steubenville, 1999) and social science (Universidad Francisco Marroquin, 2001). He is the author of many publications, including books, articles, and reviews on the subject of human rights.

Nicholas Wolterstorff (Ph.D., Harvard University) is the Noah Porter professor of philosophical theology, emeritus, at Yale University Divinity School. He has been a visiting professor at numerous schools, including Calvin College, Haverford College, University of Notre Dame, Princeton University, University of Texas, University of Michigan, and the Free University of Amsterdam. He has given the Wilde Lectures at Oxford University (1993) and the Gifford Lectures at St. Andrews University (1995). He is the author of numerous publications in aesthetics, epistemology, philosophy of religion, and political philosophy.

Rev. Maciej Zieba, O.P. (Ph.D., Catholic University of America) is the Provincial of the Polish Province of the Dominican Order and founder and director of the Tertio Millennio Institute in Krakow. Since 1991 he has lectured in the law faculty at the University of Poland and, since 1994, he has lectured at the Polish Academy of Economics.
