Uchechukwu Aladi (PhD Pontifical Lateran University) is presently the parochial vicar of St. John the Evangelist and Assumption Parish, Cascina, Archdiocese of Pisa, Italy.

Vincent Bacote (PhD Drew University) is associate professor of theology at Wheaton College and director of the Center for Applied Christian Ethics.
